### Report on the North Monterey County Unified School District's Fall 2017 California Schools Dashboard

Based upon the Local Control Funding Formula (LCFF), California has a new accountability systems that is based upon multiple measures. These measures are used to determine local education agency (LEA) and school progress toward meeting the needs of their students. The State measures are based on factors that contribute to a quality education, including high school graduation rates, college/career readiness, student achievement on state test scores, English learner progress and suspension rates.

There are several LCFF priority areas that do not meet the criteria established under state indicators. These priority areas are considered local indicators and will require the LEAs to determine whether they have Met, Not Met, or Not Met for Two or More Years for each applicable local indicator. The local indicators only apply at the LEA level. LEAs will use the local indicators to evaluate and report their progress on priority areas. The local indicators will only appear on the LEA Dashboard.

The State priority areas for Local Indicators are: Priority 1. Basic Services: Access to instructional materials, safe & clean facilities, and appropriately assigned teachers.

Priority 2. Implementation of State Academic Standards: Annual report on progress in implementing the standards for all content areas.

Priority 3. Parent Engagement: Annual report on progress toward: (1) seeking input from parents/guardians in decision making; and (2) promoting parental participation in programs.

## Approved Final Adoption of Updated Board Policies, Administrative Regulations and Board Bylaws

As recommended, the District worked with California School Boards Association (CSBA) to update all Board Policies, Administrative Regulations and Board Bylaws to ensure aligned with new legislation and requirements. The updated policies were reviewed over a three-day period of time in July and specific ones reflecting any recent legal changes between July and December 2017. This was an information item at the January 25, 2018 regular board meeting and a public hearing at the February 8, 2018 regular board meeting, and then approved at the February 22, 2018 regular board meeting. ### Approved 2017-2018 Second Interim Financial Report and Positive Financial Solvency Certification:

According to Education Code 42130 & 42131, local education agencies are required to file two interim reports during a fiscal year reporting on the financial health of the District. The Second Interim Report covers the period of November 1 through January 31 and the multi-year projection includes the January Governor's proposals for the 2018-2019 budget year. # Discuss Brief Amici Curiae of Public Schools, School Districts, and Association of Educators Regarding Permanent Injunction Against the Enforcement of Section 9 of the Executive Order:

The Educational Amici as of February 5, 2018 includes 16 California public schools, 18 California public school districts, two superintendents, and seven California associations representing 478,712 teachers, 22,400 administrators, and elected school officials. Amici schools and districts enroll approximately 1,142,170 K-12 California students and 239,959 adult and college students.

North Monterey County Unified School District was asked to consider joining the Education Amici in support of the Brief Curiae to be filed with the United States District Court of Appeals for the Ninth Circuit. However, the District was asked to reply by Friday, February 9th, which did not allow sufficient time to review and make an informed decision. The Superintendent has inquired if the District decided to join the Educational Amici and at a later date sign onto the Brief Curiae. The Education Amici representative is investigating this request.

The NMCUSD Board of Education discussed the request at the February 22nd regular board meeting. As a "Safe Haven" district, last year North Monterey County Unified School District joined many other public school districts and related educational organizations in adopting a resolution that would ensure that all students served would be treated with equity, regardless of immigration status, and be provided a free and appropriate education as required both by State and Federal Law.

### Approved Architectural Services Agreement Exhibit N with Teter, LLP for Modular Building Installation and Access Compliance project at the Central Bay Campus:

Project programming, preliminary design and estimating services for the Central Bay High School new modular classroom building installation and access compliance issues are now complete. This agreement includes creating construction documents for submission to DSA and construction administration services required of the design professional through the course of construction and final project closeout. ## Public Hearing/ Received/Adopted: North Monterey County Unified School District's Sunshine Proposal 2018-2019 Collective Bargaining with NMCFT Local

**4008** The Education Employment Relations Act (EERA) requires the District and its bargaining units to "sunshine" their initial proposals prior to commencing negotiations. The "sunshining" process is described in Government Code, section 3547. The District is required to present its initial proposal at a public meeting to enable the public to become informed and have the opportunity to express public comment.
